Subject: Proposal for amendment in CBL Committee on Morale, Ethics and Integrity

As part of effort to combat corruption, promote integrity and establish good governance at the country. Government of Bangladesh has developed National Integrity Strategy for the Country. Bangladesh Bank through its letter (ref: HR-1 (O&D) Focal-1/2013-2 dated October 10, 2013) instructed at scheduled banks & financial institutions to form an integrity committee, focal point and work plan for implementation of National Integrity Strategy in line with National Integrity Strategy (NIS) of Bangladesh. The City Bank Ltd. formed a "Committee on Morale, Ethics and Integrity" and set Terms of Reference, approved by Management in November 2013 in line with National Integrity Strategy of Bangladesh. The implementation work plan and Terms of Reference of the committee was ratified in 473rd Board Meeting. As the current position of convener is vacant, we recommend the following
